### IMPORTANT NOTES TO CLIENT

- If the registered holder of the stock is in the name of CCASS, client is required to provide the Company with the withdrawal receipt or other documents evidencing his/her ownership of the stock. Alternatively, client may transfer the stock into his/her own name before depositing the same with the Company. Otherwise, the Company will not accept the deposit of the stock. 如股票登記持有人為中央結算有限公司，客戶須提供貨收據或其他文件。證明其擁有權。另外，客戶亦可先將股票自行轉為其名下才將股票存入本公司。否則，本公司將不接受該股票存入。
- Since the transfer of the stock is valid subject to the clearance by CCASS and the relevant share registrar(s), the Company requires at least ten working days after the deposit for verification. Therefore, if client sells the stock immediately after the deposit or before the clearance of the transfer, the sale proceeds will only be payable to client ten working days after the deposit. 由於上述存入的股票需待中央結算有限公司和有關股份過戶及登記處驗證，方可作實。故此於存入股票後起計，本公司需要最少十個工作天核對股票資料。如客戶於存入股票後即時沽出股票或於驗證完成前沽出股票，所賣出股票款項將會於存股票後起計十個工作天後支付給客戶。
